

Pleasant Hill Baseball Association Volunteer Background Check Questionnaire & Declaration For those Considering Supervision & Authority Over Minors

Section 5164 of the Public Resources Code of the State of California prohibits Pleasant Hill Recreation & Park District & PHBA from hiring or utilizing the services of a volunteer to perform services at, and of its parks, playgrounds or recreational center used for recreational purposes in a position having supervision or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code. Section 5164 also authorizes Pleasant Hill Park & Recreation District and PHBA to screen any such prospective employee or volunteer for his or her criminal background. In light of your interest in being hired by Pleasant Hill Recreation & Park District and PHBA for employment at or being hired as a volunteer to perform services at any of its parks, playgrounds, or recreational centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, and in order to effect Section 5164 of the Public Resources Code of the State of California, please answer the following supplemental questions.

I hereby agree to indemnify and hold harmless Pleasant Hill Recreation & Park District and PHBA from any and all claims, causes of action, suits, actions, damages, losses, or liability arising out of termination or my employment and/or termination of my volunteer services rendered to Pleasant Hill Recreation & Park District and PHBA which may occur should any of my answers to the foregoing questions be subsequently determined to be false and/or untrue.//
